This certifies _____, herein referred to as "Mare Owner" has engaged in one service to STYLE WORTH WATCHING AmQHA # 3073056 AQHA # Q-50537, for the mare _____, Reg # _____ for the 2007 breeding season at \$1, 100.00 incl. GST . Encore Quarter Horses, EABS, and Miriam Bentley will be referred to as " Breeder", and "Agent".

This service is subject to the following terms and conditions:

FEES & EXPENSES: A non-refundable, deductible deposit of \$300.00 is payable with this contract, with the balance of stud fee, agistment, and any veterinary charges due prior to the mare being picked up from Encore Quarter Horses.

SOUND CONDITION- The Mare Owner represents, and warrants that the mare (s) are free from infection, and free from any disease. If in the opinion of the attending veterinarian any mare is NOT in sound breeding condition the Mare will not be bred. In this case, the Mare Owner may substitute another mare in the same breeding season.

BREEDING METHOD- The Breeder agrees to diligently settle the mare, and shall have sole discretion in determining the best method for breeding the mare. If however, the mare does not settle, the Breeder will be held harmless.

LIVE FOAL GUARANTEE- The Mare Owner is guaranteed a live foal. Live foal means that the foal stands and nurses for a period of one week. If the mare proves barren, aborts her foal, or if the foal is stillborn, the Mare Owner will be entitled to rebreed the mare to Style Worth Watching for no additional stud fee, during the same, or the following breeding season, provided proper written notification is given to The Breeder. Written notification within one week of the mare foaling/aborting is required from a licensed veterinarian noting that the mare has slipped, or produced a non viable foal.

NO LIABILITY-It is understood that Encore Quarter Horses, it's employees, agents, veterinarians, and guests, shall not be liable for any injury, escape, sickness, disability, or death of any horse on the premises, nor liable for failure to settle the mare. However, all necessary precautions will be taken to ensure the mare's well being.

BREEDING SEASON- The breeding season in force for this contract will start the 1st of September 2008, and close March 1st of 2009.

SUBSTITUTION- In the event that Style Worth Watching dies, or otherwise becomes unfit for service, the mare owner will have the right to use frozen semen for Style Worth Watching in the same, or following breeding year at no additional stud fee. If the mare dies, or becomes unfit for breeding, the Mare Owner may substitute with another mare.

BREEDERS CERTIFICATE- A Breeders Certificate produced by the proper association will be issued to the Mare Owner after all fees and expenses have been paid in full.

REGISTRATION PAPERS-A copy of the mares registration papers must accompany the signed contract. The recorded owner of the mare at the time of breeding will be recorded on the Breeders Certificate.

BINDING AND AGREEMENT- The contract when signed by the Mare Owner and The Breeder, and accompanied by the payment of the booking fee, shall be a binding agreement between the parties concerning the breeding of the mare, and Style Worth Watching and supersedes all other agreements, or understandings between parties whether written or oral concerning the breeding of the mare, and Style Worth Watching.
